The Board of Directors of the Idaho Vocational-Technical Education Foundation, Incorporated (who are the only members), met on October 5, 1983, and voted to amend their Articles of Incorporation. The following change was made:


SECRETARY OF STATE

Page 1, Article III, was changed to read: "The purpose of which this Corporation is formed, exclusively, is for vocational-technical educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, and the Corporation has no stated capital."

The Board of Directors voted on the change, and adopted the change by a unanimous vote.

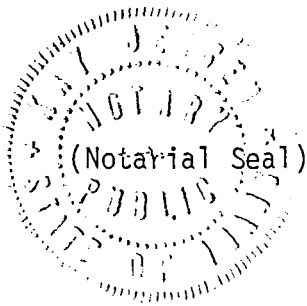

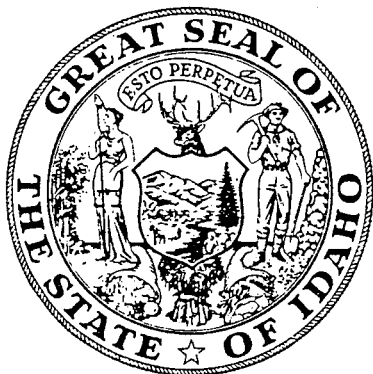
