

## ARTICLES OF AMENDMENT

The Board of Directors of the Idaho Vocational-Technical Education Foundation, Incorporated met on April 13, 1999, and voted to amend their Articles of Incorporation. The following changes were made:

Page 1, ARTICLE I, was changed to read: "The name of this Corporation shall be; Idaho Professional-Technical Education Foundation, Incorporated."

Page 1, ARTICLE III, was changed to read: "The purpose for which this Corporation is formed, exclusively, is for professional-technical educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, and the Corporation has no stated capital."

Page 1, ARTICLE IV, was changed to read: "This Corporation is created and shall be administered and operated for the purpose of promoting professional-technical education in Idaho. It is not the purpose of this Foundation to supplant state and federal funds appropriated for professional-technical education. As an amplification of said purposes and without in any way limiting the same, it is contemplated that the further purposes of this Corporation shall be:

1. To solicit, request, receive and administer funds from private business, industries, organizations, associations, individuals, and federal, state, and local governments.
2. To support specialized training programs for new and/or expanding business and industry and/or Professional-Technical Education personnel.
3. To purchase specialized kinds of instructional tools and equipment for use in local professional-technical programs.
4. To fund research which will support and promote professional-technical education programs and activities which are directed toward the advancement of professional-technical education.
5. To assist the state's efforts in economic development and job creation as related to skill training.
6. To receive instructional equipment donations and disseminate such to local programs with the advice of the State Division of Professional-Technical Education.
7. To establish a scholarship for an outstanding professional-technical education student(s).
8. To establish a revolving loan fund for needy professional-technical students.
9. To hold title to real, personal, and intangible property and to take all steps permitted by Idaho statutes to manage and control such properties.
10. To enter into contractual arrangement with any other person, partnership, corporation, or educational institution for services deemed essential to properly effectuate the purposes of the Corporation."

Page 3, ARTICLE VI, was changed to read: "The location of the principal place of business of the Corporation in this State is the State Division of Vocational Education (to become the State Division of Professional-Technical Education on July 1, 1999), 650 West State Street, Boise, Idaho 83720.

Page 3, ARTICLE VII, was changed to read: The initial address of the registered office of the Corporation in this State is Idaho Professional-Technical Education Foundation, Incorporated,



In the event employment of the aforementioned individual is terminated, his successor shall be the registered agent.

Page 3, ARTICLE IX, was changed to read: The State Administrator of Professional-Technical Education, a member of the Division of Professional-Technical Education, and one person elected annually by the Idaho Vocational Association shall be ex-officio members of the Corporation with full voting rights and other privileges and responsibilities associated with membership.

Page 4, ARTICLE X, sentence one, was changed to read: The following individuals served as the initial Board of Directors:
